

# INFEDU Author Publishing Conditions

Conditions of publication for Informatics in Education (INFEDU)

Version date: 27 June 2026

Effective date: the date this document is posted on the INFEDU website unless the Editorial Office states otherwise.

## Purpose of these Conditions

This document sets out the author warranties, author responsibilities, rights grant, and publication conditions that apply to manuscripts submitted to, accepted by, and published in Informatics in Education (INFEDU). It is intended to make the journal's publication requirements clear before and during the submission, review, production, and publication workflow.

The Editorial Office may request specific evidence or permissions where needed, for example for third-party material, ethics approvals, permissions for identifiable persons, institutional requirements, or disputed authorship.

## 1. Acceptance of these Conditions

By submitting a manuscript through the Electronic Journal Management System (EJMS), submitting a revised version, uploading final production files after acceptance, approving proofs, or otherwise permitting publication to proceed, the corresponding author confirms, on behalf of all authors, that all authors have read and accepted these Publishing Conditions.

The corresponding author warrants that they are authorised by all co-authors to act on their behalf for submission, peer review, revision, production, proof approval, publication, and post-publication communication with INFEDU.

## 2. Definitions

In these conditions, the term Paper means the submitted manuscript, accepted manuscript, final published article, metadata, abstracts, tables, figures, appendices, supplementary files, data availability statements, declarations, author biographies, and any later corrections, clarifications, errata, or retractions associated with the article.

## 3. Author Warranties and Responsibilities

- The Paper was written by the author(s) listed in the submission and final publication record, and all authors have approved the submitted, revised, and final versions as applicable.
- All authors meet the journal's authorship requirements and agree to be accountable for the accuracy and integrity of the work.
- The Paper is original, has not been published in another peer-reviewed publication, and is not under consideration elsewhere while under consideration by INFEDU, unless the Editorial Office has expressly agreed otherwise in writing.
- The Paper does not contain false, misleading, unlawful, defamatory, libellous, confidential, or otherwise improper material.
- The Paper does not infringe copyright, database rights, privacy rights, moral rights, contractual rights, or any other rights of any person, organisation, or legal entity.
- All text passages, figures, tables, data, software, instruments, images, screenshots, or other materials from third parties are properly cited and, where required, permissions have been obtained before publication.
- All funding sources, sponsor requirements, institutional requirements, conflicts of interest, competing interests, and relevant acknowledgements are fully and accurately disclosed.
- Where the work involves human participants, minors, school settings, personal data, identifiable images, sensitive data, or other regulated research contexts, the Paper includes appropriate ethics, consent, privacy, and data-protection statements.
- Any use of generative AI or AI-assisted tools in writing, data processing, analysis, image generation, translation, coding, or other parts of the research/publication process is disclosed where required by INFEDU policy.
- All references, citations, quotations, data, and methodological descriptions are accurate to the best of the authors' knowledge.
- The authors will cooperate with INFEDU in good faith if a correction, clarification, expression of concern, retraction, metadata correction, or publication-integrity investigation becomes necessary after publication.

#### **4. Copyright, Licence, and Publishing Rights**

Authors retain copyright in the Paper. The authors grant Vilnius University and the journal publishers a non-exclusive right to review, edit, produce, publish, host, preserve, archive, index, disseminate, and distribute the Paper and associated supplementary material in print, online, metadata, repository, indexing, abstracting, preservation, and other publication-related formats.

For accepted and published Papers, the authors grant permission for INFEDU to publish the Paper under the Creative Commons Attribution 4.0 International licence (CC BY 4.0), or another open licence expressly stated by INFEDU for the article before publication. Under CC BY 4.0, reuse is permitted provided that appropriate attribution is given to the author(s), article title, journal citation, DOI, and licence.

The authors confirm that they have the rights necessary to permit publication under the stated licence and that publication under that licence will not breach any obligation to an employer, funder, institution, sponsor, collaborator, repository, publisher, or third party.

#### **5. Final Publication Record**

After acceptance, authors must provide production-ready files within the deadline requested by the Editorial Office. The final version must include accurate author names, affiliations, ORCID iDs where applicable, corresponding-author contact information, acknowledgements, funding statements, ethics statements, competing-interest statements, data availability statements, AI-use disclosures, and other declarations required by INFEDU.

The corresponding author must check proofs carefully and promptly notify INFEDU of any errors in authorship, affiliations, funding, declarations, data, figures, equations, references, metadata, or content before publication.

#### **6. Withdrawal, Rejection, or Non-Publication**

If the Paper is rejected, withdrawn before acceptance, or otherwise not published in INFEDU, these Publishing Conditions do not grant INFEDU a licence to publish the Paper. INFEDU may retain submission records, correspondence, review files, and administrative metadata as necessary for editorial, audit, research-integrity, and system-record purposes. Author warranties and responsibilities relating to the submitted material remain applicable to the editorial record.

#### **7. Confirmation through the Editorial Workflow**

Authors accept these Publishing Conditions through the normal INFEDU editorial and publication workflow, including EJMS submission, revision submission, final-file upload, proof approval, or other written confirmation that publication may proceed. The corresponding author is responsible for ensuring that all co-authors have reviewed and accepted these conditions.
